The award includes the right to have shares withheld for tax purposes.
2. Employee stock option granted pursuant to the Abbott Laboratories 2017 Incentive Stock Program in a transaction exempt from Section 16 under Rule 16b-3. The option becomes exercisable in annual increments of 23,325 on February 25, 2026, 23,326 on February 25, 2027, and 23,326 on February 25, 2028.
