The award includes the right to have shares withheld for tax purposes.
- Employee stock option granted pursuant to the Abbott Laboratories 2017 Incentive Stock Program in a transaction exempt from Section 16 under Rule 16b-3. The option becomes exercisable in annual increments of 23,267 on February 17, 2024, 23,268 on February 17, 2025, and 23,268 on February 17, 2026.
