The awards include the right to have stock withheld for tax purposes.
2. Balance in the Abbott Laboratories Stock Retirement Trust as of February 16, 2006.
3. Employee stock option granted pursuant to the Abbott Laboratories 1996 Incentive Stock Program in a transaction exempt from Section 16(b) Rule 16b-3. The option becomes exercisable in annual increments of 27,667 on 2/17/2007, 27,667 on 2/17/2008 and 27,666 on 2/17/2009.
