The awards include the right to have stock withheld for tax purposes.

3. The reporting person disclaims beneficial ownership of all securities held by his wife.
4. Employee stock option granted pursuant to the Abbott Laboratories 1996 Incentive Stock Program in a transaction exempt from Section 16(b) Rule 16b-3. The option becomes exercisable in annual increments of 103,334 on 2/17/2007, 103,333 on 2/17/2008 and 103,333 on 2/17/2009.
